CONFERENCE DESCRIPTION

IBD CASE FILES, 2.0: A Program for Advance Practice Nurses, Physician Assistants and IBD Nurses will be an invaluable learning experience for practitioners seeking basic or advanced IBD knowledge. The IBD nurse specialist/physician assistant role is expanding in the areas of gastroenterology, colorectal surgery, hospital inpatient and outpatient clinic areas. Advanced Practice Nurses (APNs) and Physician Assistants (PA), as providers, improve patient access to care and play key roles in the diagnosis, treatment, and ongoing management of IBD patients. This program will provide an opportunity for APNs, IBD nurses and PAs to advance their knowledge, get answers to challenging patient care questions, and observe how evidence-based practice and research are implemented in the daily care of patients.

LEARNING OBJECTIVES

After participating in this unique, real world, case-based program, participants will be able to:

- *Describe the pathogenesis and epidemiology of Crohn's disease and ulcerative colitis.*
- *Explain the clinical features of inflammatory bowel disease.*
- *Compare, contrast and evaluate medical management strategies and surgical options for Crohn's disease and ulcerative colitis disease states.*
- *Examine the patient-caregiver relationship, and plan for ways to approach challenges encountered in its development.*
- *Identify different management concerns (pregnancy, cancer risk, psychosocial impact, etc.) and give examples of how to respond to these concerns the practice of patient care.*
