COURSE DESCRIPTION

This gynecologic oncology conference will provide access to the premier educational and scientific updates for women's healthcare professionals in Gynecological Oncology, including information and resources for members of the entire gynecologic cancer care team who provide treatment and care in the areas of chemotherapy, radiation therapy, surgery, and palliative care.

LEARNING OBJECTIVES

- Define the mechanisms of action and side effect profiles of new gynecologic cancer therapies;
- Discuss how to apply recent results regarding use of PARP inhibitors in front-line therapy of ovarian cancer;

- State how to implement new developments in surgical practice of gynecologic malignancies;
- Determine the sequencing and combination of new agents used for gynecologic cancer care with current therapies;

- Describe how ongoing trials using adoptive immunotherapy.

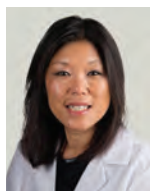
