

## CLINICAL MEDICAL ETHICS

The MacLean Center for Clinical Medical Ethics at the University of Chicago is the oldest and largest program in clinical ethics in the world and one of the oldest university bioethics programs in the United States. Clinical medical ethics is a field that examines the practical, everyday ethical issues that arise in encounters among patients, doctors, nurses, allied health workers, and health care institutions. The goal of clinical medical ethics is to improve patient care and outcomes. Since the founding of the MacLean Center and largely through the efforts of its faculty members and fellowship graduates, the study of clinical medical ethics has expanded from the bedside to encompass virtually all aspects of health care. The MacLean Center has trained more than 400 fellows in a one year full-time or part-time program. Current and former MacLean Center fellows and faculty have published more than 170 books. In October 2013, the MacLean Center received the Cornerstone Award from the American Society for Bioethics and Humanities (ASBH) for "outstanding contributions from an Institution that has helped shape the direction of the fields of bioethics and/or medical humanities."
