ABOUT THE CENTER

The MacLean Center for Clinical Medical Ethics at the University of Chicago was founded by Dr. Mark Siegler in 1984 through the generous support of Dorothy Jean MacLean, one of his longtime patients. Since its founding, the MacLean Center has focused on clinical medical ethics (CME). CME, a field largely started at the University of Chicago in 1972, addresses practical ethical issues such as truth telling, informed consent, surrogate decision making, and end of life care, that arise in routine, daily encounters among patients and all health care providers in health care institutions. However, CME also applies more broadly to the health policies and societal influences that impact how patients receive their health care. The MacLean Center sees the scope of CME to include advancing health equity by reducing disparities. We believe that this broad view of CME reflects the contemporary complex nature of how healthcare is provided. Since its founding, the MacLean Center has trained more than 650 clinical ethics fellows. Current and former MacLean Center fellows and faculty have published significant numbers of books and journal articles.
